In 2016, we continued to promote sustainable solutions to forest management and
watershed protections in Washington's South Cascades, while connecting youth and
volunteers to nature. We did this through working in collaborative groups and
providing public comments on forest management decisions, and working to protect
streams and salmon from irresponsible mining activities. We led over 30 restoration
and science trips in the forest with students and volunteers, and launched a major
new initiative to help the forest and wildlife become more resilient to the effects
of climate change.
